



## EXPRESSION OF INTEREST – Savesomtimetodream

### IMPORTANT INFORMATION

Please first consider the following expectations to assess whether you are eligible to apply.

- It is to be understood that this is a lease ONLY; the horse will remain the property of Paul Rowse with the lease managed by HRA on his behalf with a signed contract in place.
- You must commit to the lease for a minimum period of 12 months, the lease will be reviewed after this period with all parties to be satisfied in order for its continuation to occur.
- During the lease period you will be responsible for all costs pertaining to Buck's care and welfare inclusive but not limited to; feed, shoeing, worming, travel, competition, dental and veterinary costs.
- You must have the skills and experience to continue and maintain his re-education with an expectation that you will have regular lessons (monthly) with an approved, experienced coach at your own expense.
- HRA will provide free coaching sessions with Kathleen Mullan on a semi regular basis in conjunction with the above.
- Your coaching sessions may occasionally be filmed/documentated for the public to follow Buck's continuing journey.
- You must have the time, experience and financial capabilities to maintain Buck in full show condition and to compete him regularly.
- You will be expected to compete with him in both open and Standardbred events and take on an ambassadorial role for the breed.
  - This will include your public and social media presence, where criticism of HRA, the HERO Program or any other governing bodies or licensed participants will not be tolerated.
- You may be required to assist with HRV HERO promotional activities from time to time and must be willing and able to do so.
- The successful applicant will be subject to a property inspection prior to the lease being confirmed and will need to submit to regular inspections throughout the lease period to ensure Buck's continued welfare and safety.
- You must maintain regular contact and consult with HRA in the first instance should difficulties of any nature arise.
- You must be able to recognise and identify any soreness and health issues and commit to regular farrier, dental, bodywork and any necessary veterinary care to ensure Buck's welfare is of the highest standard at all times.

HRA reserves the right to revoke the lease immediately and repossess the horse if any of the above conditions are breached and/or the horse's welfare is in any way compromised.
